Jesus the Way Trust, a charitable organisation was formed during January 2008 with the objective of rendering helping hands to the socially and economically deprived women and children. We are not religious missionaries. The broader fields of the trust are Educational and Social. At present the trust has three major projects

- 1. Charitable Old age home at Chennai**
- 2. Day care children home at Periasamypuram village, Tuticorine District.**
- 3. Conduct free coaching to 60 dalit and economically downtrodden students during evening every year between July to March**

Apart from these three major projects the trust also conducts various camps such as eye screening, medical, food donation, cloth donation, training programmes such as pickle making, jewellery making, candle making etc to women, support deserving poor students to continue their studies.

The trust had statutory registration on 14th January 2008 and also registered under section 12 AA of Income Tax Act 1961, Government of India. Donations to the trust are exempted (100%) under section 80 G of Income Tax Act 1961, Government of India. The trust was granted permission to receive foreign contribution vide file No. 11/21022/67(0157)/2013-FCRA – II dated 28.10.2015 by Ministry of Home Affairs, Government of India. We have specific approval to our old age home by Government of Tamil Nadu.

Our services are supported by local contributions and donations. These LC are supporting our day to day needs to some extent. Our old age home and free coaching unit to the dalit and economically deprived poor students are functioning in rental building. Existing rented infrastructure does not meet all our needs.
